(iii) With this revised outlay, the PhD Fellowships would be enhanced from: (i) Rs. 22,500 to Rs. 31,500 (for 1st and 2nd year) and (ii) Rs. 25,000 to Rs. 35,000 (for third, fourth, & fifth year) with effect from date 01.09.2015. The Reimbursement of Rent (RoR) is directly proportional with the fellowship and hence would also be increased proportionally.
