**I. Point no. (i):** The agenda of the meeting held on 14.12.2017

There was no planned agenda. The meeting was open for discussion on Digital Economy.

**II. Point no. (ii):** The minutes of meeting held on 14.12.2017 is as follow -

The record of discussions of the Stakeholder Consultation on "Trillion Dollar Digital Opportunity" held on 14<sup>th</sup> December, 2017:

The stakeholder consultation meeting was held on 14<sup>th</sup> December, 2017, under the chairpersonship of Shri Ravi Shankar Prasad, Minister for Electronics and Information Technology with the representatives from the private sector. It was held to discuss and deliberate for the steps and strategies to be taken to reach Trillion Dollar Digital Economy. The McKinsey team presented the focus areas of the report on Trillion Dollar Digital Opportunity and the 30 digital themes that would pave the way. List of participants is enclosed.

The following major points emerge from the discussions:

- Need to strengthen joint efforts of Government and private sector. Need model RFP, payment models and efficient governance structure into National Information Utilities (NIU).
- There is an element of urgency for re-skilling and re-training with the changing scenario in the IT industry.
- Cohesive National GIS Mapping policy is required.
- Collaborative action of Government, Industry and Academia is required in the area of Cyber Security.
- Regulatory changes are required in area of Health to make the reach of doctors more effective. In the future bed less hospital may become a reality and smart software may be the new hospital.
- Need to maximize value from the data that is going to be generated.
- Expand BharatNet and create jobs.
- Collaboration on an open data platform in agriculture.
- Need to experiment with futuristic and emerging technologies.
- Need to institutionalize the data ownership framework in the country – ownership must remain with the people.
- Smart Cities security and surveillance is an area of big opportunity.
- Competitive tax policy is required for Electronics Manufacturing in India.
- Need to focus on PPP models, Artificial Intelligence (AI) solutions for the world and skill talent in AI.
- Maximise number of small businesses with access to digital.

- Digital Land records and GeM ecosystem are big opportunities.
- End- to-end Digital Supply Chain and flow based SME lending.
- Scaling up of Digital payments- Telecom Infrastructure, Incentives for merchants and convergence of multiple payment initiatives.
- Institutionalize governance framework to implement projects in new digital technologies.
- Five pillars for Digital Economy – Digital Infrastructure, Skill, Platform, Market access and Startups.
- Need to balance privacy, security and utility in using Aadhaar.
- Techno legal reforms are vital – legal reforms have to be kept up with technological change.
- Three enablers- BharatNet for broadband access, national movement for digital literacy, hackathons and other ways to support young innovators.
- Data Analytics is another big opportunity for India.
