2. Ministry of Electronic and Information Technology (MeitY) may please refer the proposal seeking clarification as to whether the power of Appointing Authority for promotion to the post of Scientist 'G' level in Autonomous Bodies were delegated to the Administrative Ministry only on introduction of Modified Flexible Complementing Scheme (MFCS) w.e.f. 01.01.2011 as mentioned in DoPT's D.O. letter dated 06.08.2010

3. The proposal has been examined in EO(SM II) Division vide ID Note No. 24/10/2006-EO(SM-II) Part dated 1.1.2019. The observations of EO (SM-II) Division are as follows:

..... this Secretariat in a similarly placed matter had already been furnished to the MeitY vide OM dated 11.08.2014 while replying a reference received from the MeitY on the implementation of the order of CAT, Bangalore Bench in OA No. 991/2012 filed by Shri Ganga Prasad CL, Scientist 'F, C-DAC, Bangalore and order of the CAT in OA No. 404/2012 filed by Shri V. Muralidharan, Scientist 'F, C-DAC Thiruvananthapuram. This Secretariat has nothing to add in the matter further.
