MeitY vide I.D. Note No. 6(01)/2018 -ABCD dated 04.02/2022 on the subject "seeking clarifications from DOPT w.r.t. the promotion case of Shri Vasant Avaghade, C-DAC on the directions of NCSC-regarding." addressed to Shri J. Sriram Murty, Under Secretary, DOPT had sought certain clarifications from DOPT. The para 7 (i) of this ID note has mentioned as follows:

"As per the facts submitted vide para 4 above, the final Appointing Authority for the post of Scientist 'G; reviewed under FCS Policy was ACC. In case of Shri Vasant Avaghade, he was also reviewed under FCS Policy. Accordingly, his case also referred to DoPT. Further, MFCS came into being w.e.f. 01.01.2011 through which the power of Appointing Authority in respect of Scientist 'G' was shifted from ACC to the Administrative Ministry which was also confirmed by DoPT vide it's OM dated 11.08.2014 and reiterated vide its communication No. 1330767/18/Estt. RR-II dated 04.01.2019. In view of the same, DoPT is requested to confirm the exact year from which the power of Appointing Authority in respect of promotion of Scientist 'G' was shifted from ACC to the Administrative Ministry."

In this context, kindly provide the certified copy of DoPT communication No 1330767/18/Estt. RR-II dated 04.01.2019 mentioned in Para 7 (i) MeitY vide I.D. Note No. 6(01)/2018 -ABCD dated 04.02/2022

The information sought has direct relevance to the antedating of promotion of the applicant to the grade of Scientist 'G' from the date eligibility. Further it has direct relevance to the petitioner's case at NCSC and also there is large public interest involved in disclosing the sought information and hence information sought information does not fall within the restrictions contained in Section 8 & 9 of the RTI Act.
