Please refer to your online RTI request Regn. No. DITEC/R/E/24/01511 seeking information under RTI Act. In this regard, as far as Digital Governance Division under MeitY is concerned the requisite information obtained from the concerned is as under:

1. Regarding the process of uploading voter ID card data on DigiLocker:

The integration of voter ID card data with DigiLocker is in its advanced stages. The process is pending final approval and data sharing from the Election Commission of India. Necessary steps are being taken to ensure the timely onboarding of voter ID cards on the platform.

2. Regarding the non-uploading of Class 10th and 12th mark sheets and certificates by the Bihar School Examination Board (BSEB):

Continuous efforts are being made by DigiLocker to facilitate the upload of Class 10th and 12th mark sheets and certificates by BSEB. Communication has been sent to the Board to expedite this process. This document is to be treated as confidential and is not to be disclosed publicly.

3. Regarding the non-uploading of degree certificates by universities in Bihar:

Higher Education Institutions (HEIs) across the country are progressively uploading academic records on DigiLocker. As of now, 45 HEIs have been onboarded to the platform, contributing to the availability of over 20 lakh academic records. The Department of Higher Education has issued directives to HEIs, including universities in Bihar, to expedite the uploading of degree certificates and other academic records."
