Sub: Seeking information under the RTI ACT, 2005

Shri Roop Kishor, Director MeitY vide Office Memorandum bearing No. 6(01) /2018-ABCD (Pt.II) dated 12.04.2022 on the subject “ *Representation of Shri Vasant* addressed to Shri J. Sriram Murty, Under Secretary , DOPT has following clarifications from DOPT:

- i. The exact year from which the power of Appointing Authority in respect of promotion of Scientist ‘G’ under FCS in autonomous bodies was shifted from ACC to the Administrative Ministry.
- ii. Whether the action of MeitY for granting promotion to Shri Vasant Avaghade after currency of major penalty over him was over, was correct in view of DoPT’s guidelines of 14.09.1992.

In the context of above, kindly provide the certified copies of the documents /documents containing the following information:

- a. *All green sheet/file notings at DOPT with respect to MeitY Office Memorandum bearing No. 6(01) /2018-ABCD (Pt.II) dated 12.04.2022 to DOPT*
- b. *Clarifications sent by DOPT to MeitY in response to MeitY Office Memorandum bearing No. 6(01) /2018-ABCD (Pt.II) dated 12.04.2022 to DOPT*

The information sought has direct relevance to the antedating of promotion of the applicant to the grade of Scientist 'G' from the date eligibility i.e. 1.7.2006 under FCS. Further it has direct relevance to the petitioner case at NCSC and NCSC directions to DOPT/MeitY to provide clarifications. Hence, the information sought does not fall within the restrictions contained in Section 8 & 9 of the RTI Act. Further Information sought has not been expressly forbidden to be published by any court of law or tribunal or the disclosure of which may constitute contempt of court. Hence it cannot be denied under section 8(1)(b) of RTI Act. Further, DOPT is the custodian of the information sought and hence information sought not be denied under section 8(1)(e) of RTI Act. too.
