Subject : Review Promotion of below group 'A' S&T personnel regarding.

Hon'ble Minister for IT has approved the following proposal for considering the below group 'A' S&T personnel as per existing Policy pending DoPT guidelines :

- i) Promotion to the next grade under FCS of Scientific Officers 'SB' (pay scale Rs.6500-10500) (Group 'B' Gazetted S&T officials) having essential educational qualification viz. B.E., B.Tech., Master's Degree in Natural Science etc. prescribed in DoPT O.M. No.2/41/97-PIC dated 9.11.98 so as to bring them in the stream of Group 'A' S&T officers.
- iii) Promotion of below Group 'A' S&T officials under FCS upto the grades (Scientist 'C') having pay scale of Rs.10,000-15200/- in respect of officers having qualification of Diploma in Engineering, B.Sc. etc.
- ii) Promotion of below Group 'A' S&T officials under FCS upto the grade having pay scale of Rs.6500-10500/- in respect of officials having qualification of matriculation with ITI certificate as also recommended by the Rajan Committee in their Report under consideration of DoPT.

STQC Dte. may now take further necessary action for reviewing the below group 'A' S&T officials mentioned above who are working in various Labs./Centers under STQC Dte. w.e.f 1.10.2001 as per existing Policy. However, the cases of SO 'SB' who are meeting qualification mentioned above may be sent to Personnel III latest by 23.8.2001 as per enclosed proforma.
