- A. The CEO will be the executive head of MeitY Startup Hub (MSH) and will work under the supervision and guidance of the Innovation, IPR and Startups Division of MeitY and Digital India Corporation (DIC), to achieve the purposes of MSH-IBD, which are as under:
- 1. Act as the nodal agency to further the above, including through evolution of a sustainable model for MSH-IBD
- 2. Assist and support the Ministry of Electronics and Information Technology in programme management of the Hub
- 3. Implementing of Startup centric MeitY initiatives in promotion of tech startups ecosystem
- 4. Promotion of innovation and entrepreneurship for tech startups in ICT&E domain
- 5. Identify gap areas in innovation promotion domain and to make an effort to fulfill these gaps to enable seamless development and growth of tech startups.
- 6. Conceptualize and evolve new programs/ schemes/ technology R&D proposals to create innovation and entrepreneurship ecosystem through promoting tech startups.
- 7. Improve performance of incubators, COEs, accelerators, and schemes funded by MeitY through robust and scalable reporting and analytical dashboard.
- 8. Promote private sector funding in startups through various investment promotion programs
- 9. Advancement in Intellectual Property creation and innovation development.
