Madam,

Please refer to your RTI request No.DITEC/R/2019/50251/2 dated 11.04.2019 addressed to DD(GC) MeitY seeking information in respect of employees of ICERT and these terms and conditions of service. The RTI application has been forwarded to GC Section for providing information in respect of medical facility & Govt. accommodation.

2. The pointwise reply is as under:

**Medical Facility**


(At present, no medical facility is available to the employees of ICERT. As per existing conditions, the employees of statutory bodies are not entitled to avail CGHS facilities.) A copy of Ministry of Health & Family Welfare's O.M. dated 9<sup>th</sup> June, 2014 is enclosed.

**Govt. Accommodation**

As per instructions, employees of statutory bodies are not entitled for govt. accommodation under GPRA. However, they can be included in the list of eligible office for govt. accommodation under GPRA with the approval of Cabinet Committee on Accommodation. The proposal of this Ministry for inclusion of ICERT in the list of eligible offices under GPRA was placed by M/o Housing and Urban Affairs before the Cabinet Committee on Accommodation. However, the proposal was not agreed to by the CCA.

OFFICE MEMORANDUM

Sub: Continuation of CGHS facilities to Central Government employees on deputation to Statutory/Autonomous bodies - reg.

The undersigned is directed to state that this Ministry has been receiving requests for continuation of CGHS facilities to the Central Government employees joining Statutory / Autonomous Bodies on short term deputation basis.

2. The matter has been considered in the Ministry and with a view to enable the Statutory / Autonomous bodies created by the Central Government, attract and motivate competent employees from Central Government Ministries and Departments, to join these organisations on short term deputation basis to improve its functioning, it has been decided to allow continuation of CGHS facilities to the Central Government employees on deputation to Statutory / Autonomous bodies during the period of deputation. The employees on deputation will be provided with an option by the organisation either to avail the medical facilities under CGHS or opt for the medical facilities provided by the organization to its employees.

3. CGHS facilities shall be provided to the Central Government employees on deputation to Statutory / Autonomous bodies, subject to the following guidelines:-


- a) CGHS facilities shall be extended to the Central Government employees joining statutory / autonomous bodies of Government of India on deputation basis, during their tenure on deputation.
- b) CGHS facilities will be extended on cost-to-cost basis on a request from the statutory / autonomous body concerned and payment of service charges in advance on yearly basis at the prescribed rates.
- c) CGHS facilities will be provided on terms and conditions as applicable to other statutory / autonomous bodies currently availing CGHS facilities. However, this will be limited only to the Central Government employees on deputation and their regular employees will not be eligible for it.

- d) Central Government employees on deputation to Central Public Sector Undertakings (CPSUs) will not be extended the CGHS facilities.
- e) This facility will be applicable only in those cities which are covered under CGHS. They will be provided dispensary facilities and the medical expenses for IPD/hospitalization treatment will be borne by the statutory / autonomous body concerned.

4. This issues with the approval of Minister of Health and Family Welfare.
