"As per the Information Technology Act, 2000, digital documents issued through DigiLocker, the flagship initiative of the Ministry of Electronics and Information Technology (MeitY), Government of India, are legally valid and enforceable documents. These documents, digitally signed through an official partnership between MeitY and respective government departments/organizations, hold the same legal sanctity as their physical counterparts when used in electronic form.

The concerned authorities are mandated to accept such digitally signed documents available on DigiLocker as valid and equivalent to original physical documents. However, the Government is actively working towards enhancing awareness and acceptance of these digital documents across various public and private organizations to ensure seamless adoption and facilitate ease of citizen services."
