Please refer to your online RTI request Regn. No. DITEC/R/E/24/00477 seeking information under the RTI Act.

In this regard, as far as the Digital Governance Divison under MeitY is concerned the requisite information obtained from the concerned is as under:

"Reply:

- 1. DigiLocker service is accessible in most countries around the world. However, as part of our security protocols, access is currently restricted in the following ten countries: China, Gibraltar, Libya, Mali, Monaco, Pakistan, San Marino, Turkey, Yemen, and Eritrea.
- 2. While we do not have specific documentation detailing the rationale, the restrictions in these ten countries have been implemented as a security measure to ensure the safety and integrity of the DigiLocker platform and its users' data.
- 3. The Ministry of Electronics and Information Technology (MeitY) has not issued any formal correspondence, circulars, or notifications regarding the geographical accessibility of DigiLocker. The restrictions were put in place as part of our internal security protocols.
- 4. At present, there are no specific plans or discussions within MeitY to make DigiLocker accessible in the ten restricted countries mentioned above. Any future decisions in this regard will be based on a comprehensive assessment of security considerations.
- 5. We do not have any additional documentation to provide related to the accessibility of DigiLocker outside India, beyond what has been mentioned above regarding the security-based geo-restrictions in the ten countries."
