Subject: Minutes of the Meeting of Screening Committee held on 09.11.2016 at 2.30 p.m. for consideration of applications for appointment on Compassionate Grounds in MeitY

A meeting of Screening Committee constituted for considering the cases for Compassionate Appointment in the Ministry of Electronics and Information Technology was held on 09.11.2016. The Committee comprises the following:

All the above person attended the meeting.

- 2. The points for consideration before the Committee were:
 - i) Inclusion of 03 (Three) fresh applications of the following candidates in the pending list for Compassionate Appointment:
 - a) Request of Smt. Santosh, w/o Late Shri R.K.Antil, Ex-UDC for appointment of her son Sh. Pradeep Kumar.
 - b) Request of Smt. Santosh Kumari, W/o Late Shri Raj Kumar, Lab Assistant 'B' for appointment of her son Shri Mahesh Kumar.
 - c) Request of Smt. Malti Devi, w/o Late Shri Jai Dev Rai, Ex-LDC for appointment of her son Shri Nishant Rai.
 - Whether the candidature of Smt. Meena Devi w/o Late Sh. Dig Ram, Ex. Chair Recainer-cum-Polishman is to be dropped for want of required information along with income certificate from her in the light of Communication and subsequent reminders having been received back un-delivered from the postal authorities.
 - (iii) To adjudge the suitability of the candidates for appointment on Compassionate grounds based on the criteria followed by Department of Posts mentioned in their letter No. 37-36/2004-SPB-1/C dated 20.01.2010 (Annexure –I) and adopted by this Ministry with the approval of Competent Authority as well instructions issued by DOPT in the matter (Annexure-II). The details of pending applications for compassionate appointment are as follows:
 - a) Smt. Meena Devi, W/o late Shri Dig Ram, Ex-Chair Recainer- Cum- Polishman.
 - b) Sh. Sachin Kumar, S/o Shri Phool Chand, Ex-UDC, Mother: Smt. Kaushalya Devi
 - c) Sh.Sanjeev Kumar, S/o Shri Sohan Lal, Ex-Peon, Mother: Smt. Sumitra Devi
 - d) Sh. Vipin Singh, S/o Late Shri Mahipal Singh, Ex-Head Chowkidar, Mother: Smt. Uma Devi.
 - 3. For adjudging the suitability of candidates, Committee deliberated on the above issues/points in the light of criteria fixed by Ministry, Govt's instructions on subject matter and information provided by applicants against the inputs sought by Personnel Div, MeitY. Summary sheet of the points earned by each applicant based on the criteria adopted by the Ministry was also taken into account (Annexure-III). After detailed discussions, the Committee recommended as under:
 - (i) Inclusion of three fresh applicants (as indicated at para 2 (i) above) in the pending list for consideration along with the four other pending cases as indicated at para 2(iii) above.

- Shri Vipin Singh, s/o Shri Mahipal Singh, Ex-Head Chowkidar, (mother Smt. Uma Devi) to be offered appointment on Compassionate grounds (ii) keeping in view mainly the following besides other aspects:
 - Shri Vipin Singh earned 55 merit points which is the highest amongst (a) all the seven listed candidates.
 - Shri Vipin Singh has three dependents (mother and two unmarried (b) sisters) at present.
 - The applicant has no Moveable/Immovable Property at his disposal. (c)
- Keeping in view the educational qualifications of Shri Vipin Singh, the (iii) Committee also recommended that efforts may be made to offer him appointment at appropriate level in Group "C" grade as per the Scheme of Compassionate Appointment.
- As regards cases of: (1) Sh. Sachin Kumar, S/o Late Shri Phool Chand, ex-(iv) UDC, (2) Sh. Sanjeev Kumar S/o Late Shri Sohan Lal, ex-Peon, (3)Shri Pradeep Kumar S/o Late Shri R.K.Antil, ex-SSA, (4) Shri Mahesh Kumar, S/o Shri Raj Kumar, Ex- Lab Assistant and (5) Shri Nishant Rai, S/o Shri Jai Dev, Ex-LDC, the Committee took note of their particulars and the information in the relevant attributes meant for relative merit points and recommended to keep them in the pending list.
- With regard to the candidature of Smt. Meena Devi W/o Late Shri Dig Ram, (v) Ex- Chair Recainer cum Polishman, the Committee after due deliberation decided to retain her candidature also in the pending list.
