

**Record of Discussion**

A Video Conference (VC) Meeting with **Delhi, Jharkhand, Kerala, Maharashtra, Manipur and Meghalaya** was held on **7<sup>th</sup> May, 2019** at 11:00AM in AS Conference Room, 4<sup>th</sup> Floor, MeitY, under the Chairmanship of Director (eGovernance), MeitY, for identification of e-Services and its development under CSC-2.0 project along with a review of implementation of eDistrict MMP & closure of CSC Scheme.

2. A list of all the participants has been placed at **Annexure-A**.
3. Director (eGov), MeitY, welcomed all participants and discussed the current implementation status of eDistrict MMP.
  - i. Representative of Delhi conveyed that total number of 87 e-Services have been launched so far under eDistrict portfolio, in all 11 districts of Delhi. Integration with CSC's Digital Seva (DS) Portal is under process of approval.
  - ii. State representative of Jharkhand stated that 24 e-Services were launched out of 30 approved e-Services in all 24 districts of State. Work is in progress for remaining e-Services. All eDistrict e-Services were integrated with CSC's DS Portal.
  - iii. Kerala State representative stated that 49 e-Services are available in all 14 districts and delivering the e-Services by State's Akshaya Centers. It was also requested to integrate CSC's e-Services with Akshaya Web Portal.
  - iv. Representative of Maharashtra conveyed that 52 e-Services are available under eDistrict service portfolio in all 35 districts of State. All the e-Services are being delivered by State's MahaOnline portal, which have already been integrated with CSC's DS portal.
  - v. Representative from Manipur said that 35 e-Services are available in all 16 districts.
  - vi. Representative from Meghalaya stated that 13 e-Services out of 32 approved e-Services have been launched in all 11 districts. Work is in progress for remaining e-Services.
4. Further, it was highlighted that erstwhile CSC Scheme was closed in 31<sup>st</sup> March, 2017, for which MeitY has already issued D.O. letters and reminders to complete the formalities and submit the project closure report.
5. Director (eGov), MeitY said that under CSC-2.0 there is a mandate to develop the e-Service application of identified G2C e-Services in the States/UTs by its implementing agency, i.e. CSC eGovernance Services India Limited (known as CSC -SPV) and technical support for 3 years. Hence, it would be desired that respective States/UTs may identify 20 additional G2C e-services for further expansion & delivery of e-Services to the citizens. Further for better coordination between States and CSC -SPV, it was requested to identified a nodal officer and submit his/her contact details (*mobile & email*) to MeitY.
5. In addition, Director (eGov), MeitY quoted the roll-out guidelines of eDistrict MMP and CSC-2.0 project, where States/UTs were requested to integrate all their G2C e-Services with National Level Digital Seva (DS) Portal of CSC -SPV, for the ease of service delivery to the citizens up to village, blocks & gram panchayat level. It was also requested that all the State G2C e-Services should be integrated with Rapid Assessment System (RAS) for collecting citizen's feedback to improve their performance and with National Level eTaal portal for transactional count & analytical aspect.

6. In this context, Director (eGov), MeitY requested to States/UTs to propose a suitable date to conduct a full day sensitization workshop for State Government officials of all the line departments to emphasise the importance of IT &IT enabled services of MeitY such as CSC-2.0, eTaal-2.0, Open Government Data (OGD/NDSAP), ePramaan and Rapid Assessment System (RAS).
7. After detailed discussion and deliberation, the following were recommended:
- i. To submit the list of approved & launched e-Services in respective States/UTs under eDistrict MMP as on 31<sup>st</sup> March, 2019 along with all the necessary documents suggested under roll-out guidelines of eDistrict MMP.
  - ii. To submit pending UCs of eDistrict MMP & CSC Scheme along with Project Closure Report. Kindly refer financial details at **Annexure-B**.
  - iii. To complete integration of all State's G2C e-Services with CSC's DS Portal, eTaal-2.0 and RAS.
  - iv. To identify 20 additional G2C e-Services for further development by CSC -SPV under CSC-2.0 project, without any financial implications.
  - v. To nominate a nodal officer to coordinate with MeitY & respective implementing agencies for further integration and development of additional 20 e-Services and share his/her contact details by 20<sup>th</sup> May, 2019.
  - vi. To issue a letter for conducting a full day sensitization workshop to the States/UTs so that the respective State/UT may propose a suitable date for the same.

The meeting concluded with a vote of thanks to and from the Chair.
