In this regard, as far as Digital Governance Division under MeitY is concerned the requisite information obtained from the concerned is as under:

"1: Regarding degree/diploma certificates in DigiLocker by recognized universities - DigiLocker operates under the Ministry of Electronics & IT as a digital document platform. When certificates appear in DigiLocker, it confirms that the issuing institution is an authorized partner and the document is digitally signed and legally valid under IT Act, 2000. However, DigiLocker only verifies document authenticity and does not determine the recognition status of individual courses. Course recognition must be verified separately through UGC or relevant regulatory bodies.

2: Regarding unrecognized courses and DigiLocker issuance - Only institutions recognized by statutory bodies (UGC, AICTE, State governments) can become DigiLocker authorized issuers. The system only allows issuance of certificates for recognized programs. Therefore, if a course is not recognized by UGC or relevant authorities, its certificates cannot be issued through DigiLocker. For course recognition verification, please check with UGC or the concerned regulatory authority."
