In this regard, as far as the Digital Governance Division under MeitY is concerned, the requisite point-wise information obtained from the concerned is as under:

- "1. As of now, the certificates for the 2015 High School and 2017 Intermediate examinations issued by the Uttarakhand Board of School Education have not been uploaded on DigiLocker.
2. The reasons for the non-upload of these certificates are currently being addressed and are under active consideration. The DigiLocker team is in continuous communication with the Uttarakhand Board of School Education to resolve any issues that may have led to the delay.
3. While there is no specific deadline set at the moment, the DigiLocker team is working in collaboration with the board to expedite the process of uploading these certificates.
4. As of now, no specific deadline has been established for the uploading of the certificates on the DigiLocker platform. However, updates regarding the progress of this initiative will be communicated through the DigiLocker app once the certificates are successfully uploaded."
