Whereas, RTI Application bearing Regn No.DITEC/R/E/22/00331 dated 28.03.2022 of Shri Vasant Avaghade has been received by CPIO of ABC Division in this Ministry for seeking information under the RTI Act, 2005.

2. Whereas, Shri Vasant Avaghade has preferred First Appeal bearing Regn No. DITEC/A/E/22/00068 dated 29.04.2022 against his above noted RTI Application stating that the CPIO has refused access to information requested, under the RTI Act, 2005.

3. Whereas, the aforesaid RTI application of Shri Vasant Avaghade has been examined in this Ministry and has been replied by the CPIO vide this Ministry's letter dated 22.04.2022.

4. Whereas, the appellant has stated that information sought in the RTI application Regn No. DITEC/R/E/22/00331 dated 28.03.2022 has been refused by the CPIO, it is observed that RTI application was replied within prescribed time limit from the date of receipt by the CPIO.

5. Whereas, it is also stated that in compliance to Appellate Authority's Order No.9(2)/2021-ADCD dated 10.11.2021, all available documents of Shri Ganga Prasad GL case containing 143 pages have already provided vide CPIO letter No.9(2)/2021-ABCD dated 03.12.2021 to Shri Vasant Avaghade, free of cost in PDF Format through email. The matter pertaining to Shri Ganga Prasad GL is presently under submission/consideration and final decision is yet to be taken by the competent authority.

6. Whereas, it is observed that RTI application Regn No. DITEC/R/E/22/00331 dated 28.03.2022 of Shri Vasant Avaghade has already been replied by the CPIO vide this Ministry's letter dated 22.04.2022.

7. Therefore, the present Appeal of Shri Vasant Avaghade is hereby disposed off with the remarks that the RTI application Regn No. DITEC/R/E/22/00331 dated 28.03.2022 has already been replied by the CPIO vide this Ministry's letter No.9(15)/2022-ABCD dated 22.04.2022.
