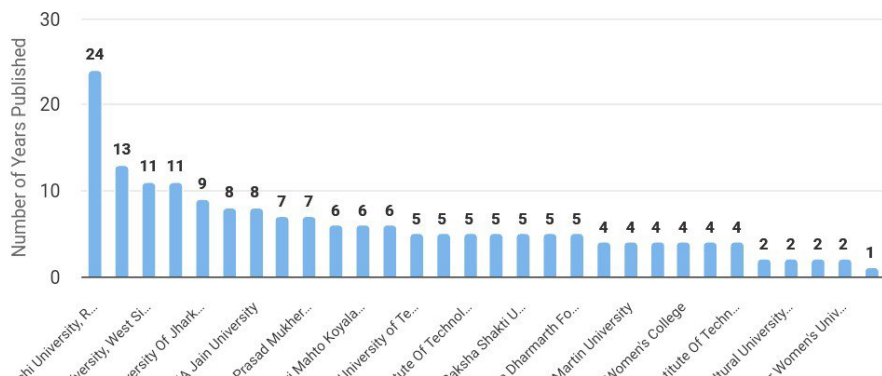

Please refer to your online RTI request Regn. No. DITEC/R/E/24/01359 dated 06.11.2024 seeking information under the RTI Act, 2005.

In this regard, as far as Digital Governance Division under MeitY is concerned the requisite information obtained from the concerned is as under:

"With reference to your query regarding the discrepancy between the statistics shown on DigiLocker's website and the actual availability of Radha Govind University, Ramgarh (Jharkhand) documents on the DigiLocker application, we would like to clarify the following:

While Radha Govind University has successfully onboarded onto the DigiLocker platform and uploaded 2,281 records as reflected in our statistics, **the university has not yet requested to make these records live and accessible through the DigiLocker application.** As per standard operating procedure, educational institutions must explicitly request to go live after completing the onboarding and data upload process. Only upon receiving and processing such a request from the university will their records become visible and accessible to students through the DigiLocker platform."
