## RTI Reply Reference number: DITEC/R/E/22/00510

Total 17, 236 beneficiaries were certified in Kerala under NDLM scheme and 20,438 beneficiaries are certified under PMGDISHA scheme till today. The impact assessments of both the schemes are done by IIT Delhi and CSD.

- 1. The assessment report of NDLM scheme states that 63.03 per cent of the respondents who received the training are able to use the digital devices to check and send emails. The response rate for this was high in the states of Rajasthan, Gujarat, Delhi, Punjab, Kerala and Maharashtra.
- 2. The assessment report of PMGDISHA states that overall 67.24 per cent and 61.94 per cent of the trainees reported improvements in their ICT knowledge, and in their general awareness levels, respectively. The current assessment study for training conducted under PMGDISHA scheme highlighted that the beneficiaries feel the training was good and learning new skills has made them confident to lead a better life and support their family in various aspects.

The information regarding the caste, gender, age and education level of students registered under the scheme cannot be shared as the information sought by you in point is denied under Section 8(1) (j) of Right to Information Act, 2005 the information sought cannot be shared, as the information relates to personal information the disclosure of which has not any relationship to any public activity or interest and would cause unwarranted invasion of the privacy of the individuals.
