(i) IT for Masses programme: The programme is under Manpower Development Scheme of Digital India Programme (umbrella scheme) and is aimed at narrowing the digital divide by initiating/promoting activities in ICT for focus groups (Women, Scheduled Caste, Scheduled Tribe, Senior Citizen, Differently Abled & Economic Weaker Section (EWS) and areas (North Eastern Region, Backward Districts and Blocks & Districts having more than 40% SC/ST population) for inclusive growth of IT Sectors through Infrastructure Creation, Training, Capacity Building & Entrepreneurship Creation activities in IT domain. The GIA has been released from Tribal Sub Plan head of Manpower Development Scheme. The project-wise details of the funds released is stated below:
