Expediting rollout of Common Services Centres (CSCs) under CSC 2.0

Dear

Kindly refer to the DO Letter vide even no. dated-9th December 2015, regarding implementation guidelines of CSC 2.0 Project under Digital India. In pursuance of the Government's commitment to set up 2.5 lakh CSCs at Gram Panchayats with at least one CSC in each Gram Panchayat, it was proposed to conduct selection of VLEs for the new CSCs during the month of December 2015 and train these new VLEs in January 2016. In this regard, the implementing agency- CSC e-Governance Services India Limited (CSC SPV) has already circulated all necessary memorandums pertaining to constitution of selection committee, hiring manpower support at District and State levels, advertisement etc., which are also available at http://deity.gov.in/content/other-projects-initiatives.

2. Keeping in view of the Government's commitment, it is proposed to setup CSCs in all the Gram Panchayats across the country by March, 2016 in order to make the public services accessible for all rural citizens. The State Governments and UT Administrations are making all efforts to rollout the same. However, the progress needs to be accelerated.
