Ministry of Electronics and Information Technology Major achievements Month of May, 2020

The significant developments pertaining to Ministry of Electronics and Information Technology for the month of May, 2020 are as given below:

I. Important Policy decisions taken and major achievements during the month:

1) National Informatics Centre

- i) One Nation-One Ration Card: NIC has developed a S/w to implement "One Nation One Ration Card", under IMPDS Scheme of Dept. of Food & Public Distribution to ensure that resident of a State can take ration from any other State in India. 17 States are already on boarded for National portability.
- ii) During the present COVID crisis, following activities have been undertaken by NIC:

RT-PCR and Rati Mobile Apps: NIC has developed RT-PCR and Rati Mobile Apps on Android and iOS platforms and a web portal to ensure, quality and accurate data of patients at location for surveillance, immediate transfer of Sample details to ICMR for use by authorized laboratories:

- **RT-PCR Test of India App:** The App is used by collection Centre technicians to enter details of the samples being collected for Covid-19 RT-PCR test. It helps in preparing SRF form which is sent along with the Sample to Laboratory.
- **RATI (Rapid Antibody Test of India)App:** RATI App captures test results data of Rapid Antibody Tests. The App is used by collection Centres conducting the Rapid Antibody Test for COVID-19, on behalf of ICMR.
- **Web Portal**: The Web portal at https://covid19cc.nic.in ensures authorizations of sample collectors and testers across country with viewing rights to Government officials at State and District level.
- GIS Based Covid-19 Care Integration in OneMap Greater Noida Portal: NIC developed 'GIS Based Covid-19 Care' module of OneMap Greater Noida Portal is incorporated with Total Covid Hotspots & Hotspot Sectors Buttons, providing varied information (1Km BufferZone) to demarcate the locations for containment.
- **OGD:** Open Government Data Platform, India has created a live dashboard on COVID19 with datasets sourced from MoHFW. Infographics, data-visualization, analytics, Health Infrastructure open data etc., are also available in the dashboard page.

2) National e-Governance Division (NeGD)

- NeGD has initiated a webinar series for capacity building for Government officials and State e-Mission Teams.
- The mobile App, 'Aarogya Setu" enables people to assess themselves the risk of their catching the Corona Virus infection and calculates the risk based on their interaction with others, using cutting edge Bluetooth technology and other algorithms.

In a major push for privacy, transparency, and accountability, Aarogya Setu has made its code open source for the Android client. A bug bounty programme for the app has also been launched.

Important developments under MeitY's Schemes:

- As on 31st May, 2020, total number of Aadhaar generated are 125.80 crore against the 'projected population 2020' of 137.14 crore. Aadhaar saturation (Projected Population 2020) across India stands at 88.6%.
- Total number of e-Services registered in eTaal till 31st May, 2020 is 3,858
