Please refer to your online RTI request Regn. No. DITEC/R/T/24/00667 seeking information under the RTI Act, 2005.

In this regard, as far as Digital Governance Division under MeitY is concerned the requisite information obtained from the concerned is as under:

"Based on our analysis, the issue appears to be related to the partial upload of academic records by IEC University to the National Academic Depository (NAD) portal, which is integrated with the DigiLocker system. As of now, IEC University has only uploaded degree and diploma certificates to the NAD portal, but the digitization and upload of individual marksheets, including your DiPharma marksheet, is still ongoing.

Therefore, if you are unable to access your DiPharma marksheet through the DigiLocker platform, we recommend that you directly contact the IEC University administration and request them to expedite the process of uploading your academic records to the NAD portal. This will ensure that your marksheet and other relevant documents are made available through the DigiLocker system, allowing you to access and verify your credentials as needed."

2. If you are not satisfied with the information, you can make an appeal to the following Appellate Authority against the information provided.
