OFFICE MEMORANDUM

Subject: Filling up the posts of Senior Secretariat Assistant in Department of Electronics & Information Technology on deputation basis- reg.

It is proposed to fill up the 16 vacant posts of Senior Secretariat Assistant in Department of Electronics & information Technology in Pay Band (PB-1) of Rs. 5200-20,200/-plus Grade pay of Rs. 2400/- on deputation basis initially for a period of one year, extendable upto three years. The eligibility conditions, experience etc. for the posts are given at the Annexure-I.

2. The period of deputation including period of deputation held against another ex-cadre post immediately preceding this appointment in the same or some other organization shall not ordinarily exceed three years. The maximum age limit for appointment on deputation (including short term contract) shall not be exceeding 56 years as on closing date of receipt of applications. The terms & conditions of deputation and pay & allowances will be governed in accordance with the Department of Personnel & Training's O.M. No. 6/8/2009-Estt (Pay-II) dated 17.06.2010, as amended from time to time.

3. It is requested that the particulars in the prescribed proforma (**Annexure-II**) of eligible and willing persons who can be spared immediately may be sent to this Department along with their up-to-date Confidential Report/APAR Dossiers for the last five years and Vigilance Clearance /Disciplinary Clearance to the undersigned at the above mentioned address on or before 01.08.2016 till 5.00 P.M.

4. Applications received after the due date and without CR dossiers and Vigilance Clearance/Disciplinary Clearance will not be entertained under any circumstances. The official once selected shall not be allowed to withdraw his/her candidature at a later date.
