# **Buyer Added Bid Specific Terms and Conditions**

### 1. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 4. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

### 5. Generic

Buyer Organization specific Integrity Pact shall have to be complied by all bidders. Bidders shall have to upload scanned copy of signed integrity pact as per Buyer organizations policy along with bid. <u>Click here</u>

### 6. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. In the event of an inconsistency, conflict, or ambiguity between the terms and conditions of GeM Bid document and uploaded RFP, the terms set forth in the uploaded RFP shall prevail.

2. The Electronic Performance Bank Guarantee (ePBG) would have to b e deposited by the awardee of the contract within 15 days of the date of award of contract. The amount of ePBG would be @ 3% of the contract value. ePBG should be in favor of "The Pay and Accounts Officer", MeitY and valid upto 3 years. The advisory bank is Bank of India (BOI). (Section 2.5.4

of the RFP for "Contract Finalization and Award").

3. The work under this tender is not assignable by the agency. The agency shall not assign its contractual authority to any other third party. The agency should not assign or sublet the whole work or any part of it to any other agency in any other form than defined in this tender. If found doing so, it may result in termination of contract and forfeiture of Security Deposit (PBG)

4. In case the agency is found in breach of any condition(s) of tender, at any stage, legal action as per rules/laws, shall be initiated against the agency and Security Deposits (PBG) shall be forfeited, besides being liable to be debarred and blacklisted for at least three years.

5. No commitment of any kind, contractual or otherwise shall exist unless and until MeitY has executed a formal written contract. MeitY may cancel this tender at any time prior or after the signing of agreement

6. MeitY without assigning any reason can reject any tender(s), in which any prescribed condition(s) is/ are found incomplete in any respect and at any processing stage.

7. The decision of MeitY arrived during the various stages of the evaluation of the bids is final & binding on all bidders

8. Conditional bids are not acceptable and shall be summarily rejected.

9. The onus of providing the correct information/ documents lies on the bidder. The bidder shall ensure that all information/documents submitted by it are correct. Upon verification, evaluation/ assessment, if in case any information furnished by the bidder is found to be false/ incorrect, their total bid shall be summarily rejected.

10. MeitY will not be responsible for any misinterpretation or wrong assumption by the bidder, while responding to this tender.

11. MeitY may terminate the tender process at any time without assigning any reason. MeitY may, by written notice send to the Agency; terminate the work order, in whole or in part at any time of its convenience.

12. All bidders agree with MeitY for honoring all aspects of fair-trade practices in executing the work orders placed by MeitY.

13. In the event of Agency or the concerned division of the company being taken over/ bought over by another company, all the obligations and execution responsibilities under the agreement with the MeitY, should be passed on for compliance by the new company in the negotiation for their transfer.

14. In case if Agency is found in breach of any condition(s) of tender or work order, at any stage during service, appropriate action as per rules/ laws, may be initiated against the Agency and Security Deposit (PBG) shall b e forfeited, besides debarring and blacklisting the bidder concerned for at least three years, for further dealings with MeitY.

15. The bidder shall be solely responsible for discharge of all the legal obligations/ statutory requirements under various labor legislations as may be in force from time to time so far as the workmen engaged by him for this work are concerned. Such engaged manpower or the bidder will have no right or claim of any kind from MeitY.

16. Outsourcing/ Consortiums/ Sub-contracting is not allowed for the purpose of participating in this tender.

## 8. Payment

# Disclaimer
